## **Saturday, May 21, 2022**

Some old roads, some new roads – while avoiding freeway and busy highways - all at a spirited pace through rural Willamette Valley in Clackamas, Marion, Yamhill and Washington Counties

PLEASE have a full tank of fuel and empty bladders!

The tour is 100 miles long and will take about 3 hours including the 30-minute rest stop.

Enjoy the roads and scenery, but PLEASE share the road and watch out for pedestrians and bicyclists.

We will meet at 9:30 AM in the Back Parking Lot at the I-5 Southbound French Prairie Rest (Baldock) Area south of Wilsonville. Drivers meeting will be held at 9:45 AM. We will depart promptly at 10:00 AM.

The 30-minute rest stop is 1 hr 20 mins (58 miles) into the tour at the Pilot Truck Stop, 4220 Brooklake Rd NE, Salem, OR 97303.

Destination is at the McMenamins Wilsonville Old Church & Pub, 30340 SW Boones Ferry Rd, Wilsonville, OR 97070.

#### Some Information for the Tour:

- You will NOT enter any gravel roads (save for vineyard access road).
- You will NOT drive on any gravel roads.
- You will NOT enter onto or drive on any residential driveways.
- You will NOT enter onto any "Dead End" posted roads.
- When turning: "Bear" is substantially less than 90 degrees, "Acute" is substantially more than 90 degrees.
- You will "zero" your trip odometer at the start of the tour, and after the rest stop. Mileage readings will help you follow the instructions.

**ZERO VEHICLE (OR GPS) TRIP ODOMETER** at the Stop as you exit from the rest area parking lot - your vehicle's indicated mileage may not follow exactly, but it helps with the task of navigation.

- 10.25 Observe SPEED LIMIT 35 (sign is here for a reason don't learn why!)
- 10.35 Observe SPEED LIMIT 35 (ditto!)
- 10.55 Observe SPEED LIMIT 25 (ditto!)
- 10.60 Observe Ehlen Rd NE becomes Main St NE, which becomes 1st St NE, which becomes Liberty St NE (all in 0.2 mile!)
- 10.80 Left at Signal onto Hwy 99E
- 11.15 Bear Right onto S Lone Elder Rd
- 12.40 Straight at Stop to remain on S Lone Elder Rd (at Barlow Rd)
- 13.90 Right onto S Bolland Rd (please respect the 25 MPH speed limit)
- 15.60 Left at Stop onto S Gribble Rd
- 16.05 Straight onto S Oglesby Rd

- 35.45 Left onto S Oster Rd (caution narrow bumpy road, some loose gravel, unknown if the cows were taken back to the barn for milking this morning!)
- 36.40 Caution loose gravel and short unpaved section (10 feet)
- 36.60 Straight to remain on S Oster Rd
- 38.25 Caution watch for gravel, potholes and uneven road surface
- 38.30 Left at Stop onto S Monte Cristo Rd Please don't throw gravel behind you as you turn onto S Monte Cristo Rd!
- 38.80 Bear Left at Stop onto S Barlow Rd

- 56.84 Straight at Signal to remain on Brooklake Rd NE (at Hwy 99E)
- 57.75 Observe passing under I-5 on Brooklake Rd NE

57.78 - Merge Left into left turn lane

57.90 - Left into Pilot Truck Stop (first possible left after I-5)

Try to park together. There may be more parking space to the Right then Left by the Carls Jr.

We have a 30-minute stop here. We have about another 1 hr 10 mins of tour.

Proceed West through Pilot parking lot, and on to between the new Space Age / US Market (on right) and Carls Jr (on left) parking lots to Truckman Way NE.

Pull Forward to white line at Truckman Way NE

HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoter, participants, racing association, sanctioning organization or any subdivision thereof, track operator, track owner, officials, car owners, drivers, pit crews, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "releasees", from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefor on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in or upon the restricted area, and/or, competing, officiating in, observing, working for, or for any purpose participating in the event;
- 2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.
- HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
