For me the best seafood is often found in quirky, small family owned restaurants. I favor those with a view of the water. "If you can't see the Ocean don't order the fish!"

All this is a polite way of saying that if a restaurant is large enough, and organized enough, to seat us all, it likely won't have the best seafood. A better plan is to scatter in groups of 2, 4 or 6 and explore the possibilities. There are a lot of great choices within a few miles. You won't be disappointed.
